### PAYMENTS:

Residents pay tuition, fees, and housing charges all in one location simply by logging into their USU Banner Access account at [www.usu.edu/myusu](http://www.usu.edu/myusu). The Banner Access system only serves as a cashier for Housing payments, any questions related to housing charges still need to be directed to the Housing Office. Any balance owing on the Student's Banner Access account, whether for Housing, Dining, or other University charges, could prevent registering for classes, will drop classes, and prevent the Student from using their activity card, etc. If financial aid or scholarship, funds are to be used, funds are allocated to tuition and fees first and then housing and dining. If financial aid or scholarships have not been awarded yet or there will not be enough funds to cover tuition, fees and housing, the Student will be responsible to pay the balance of their housing and dining (if applicable) payment by the University designated due date or classes will be dropped.
